Civic education – thematic meeting

The event comprises of a compact day of workshops discussions and experience exchanges aimed at setting a concrete framework for lessons learnt and possible further steps to be taken to strengthen civic education and its role across the borders. The second day of the event will give possibility for interested representatives of the participating organizations to meet without the constraints of a formal program either at the headquarters of participating Norwegian organizations (if they are Oslobased), at the premises of the NHC (which we will make available for this purpose) or at any other location of choice.

For the purpose of the meeting we define civic education as encompassing the definitions of both education for democratic citizenship and human rights education as outlined in Council of Europe's Charter on Education for Democratic Citizenship and Human Rights Education¹.

As the charter rightly identifies, education plays an essential role in the promotion of core values such as democracy, human rights and rule of law as well as in prevention of human rights violations. Education is also increasingly seen as a defense tool against the rise of violence, extremism, populism, xenophobia, discrimination and intolerance.
